15	Moved Buildings - For all moved buildings, (1)the well and septic serving a building being moved off site must be properly abandoned and closed within 60 days of moving; (2) a \$500 deposit is required at permit issuance toward well and septic abandonment costs and shall be refunded upon presenting satisfactory evidence of well and septic closure and (3) a building permit is required.
