VOTING BY ABSENTEE BALLOT SPRING ELECTION April 2, 2019

Any qualified elector who is unable or unwilling to appear at the polling place on Election Day may request to vote an absentee ballot. A qualified elector is any U.S. citizen, who will be 18 years of age or older on Election Day, who has resided in the ward or municipality where he or she wishes to vote for at least 10 consecutive days before the election. The elector must also be registered in order to receive an absentee ballot.

TO OBTAIN AN ABSENTEE BALLOT, YOU MUST MAKE A REQUEST IN WRITING.

Contact our municipal clerk, Gail Anderson, and request that an application for an absentee ballot be sent to you for the election. You may also request an absentee ballot by letter. Your written request must list your voting address within the Town of Troy, the address where the absentee ballot should be sent, if different, and your signature.

Included with your request for an absentee ballot, you must include a copy of an acceptable form of Photo ID.

Special absentee voting application provisions apply to electors who are indefinitely confined to home or a care facility, in the military, hospitalized, or serving as a sequestered juror. If this applies to you, contact our municipal clerk, Gail Anderson.

You can also personally go to the clerk's office at 654 Glover Road, Hudson, during the absentee voting hours, complete a written application, provide Photo ID, and vote an absentee ballot during the hours specified for casting an absentee ballot.

The town is also looking at future improvements for Bjerstedt Lane. At this time, we are analyzing soil borings taken and working with our engineering firm, Cedar Corporation on improvement options.

Troy's Farmland Preservation-

Troy has a history of protecting its farmland.

Several years ago, Troy established its own Zoning Code to have more control over development in the town. In the process we were not able to comply with State and County Farmland Preservation rules and farmers lost eligibility to claim certain state tax credits. Last year, in communicating with the State of Wisconsin Department of Agriculture, Trade and Consumer Protection (DATCP), who runs the Farmland Preservation program, we learned the rules had changed which would allow our town to establish its own ordinance for its farmers to participate in. A committee was formed and they worked with staff, state, and county employees to help Troy put its program in place. There are two separate programs that owners of farmland may be able to participate in to qualify for tax credits.

Our updated zoning code now allows most owners of farmland zoned Exclusive Agriculture to qualify for state tax credits if they are a Wisconsin resident, the land produced at least \$6,000 in gross farm revenue in the previous year (or \$18000 in last 3 years), and they comply with soil and water conservation standards (Nutrient Management Plan). St Croix County Land Conservation Department issues the certificate- but farms need to qualify the spring previous to the year you receive the tax credits. Another avenue for state tax credits is the Agriculture Enterprise Area (AEA) - this includes a large part of the township's Exclusive Agriculture District that is contiguous and the landowner would need to sign up with the state for 15 years to keep it in Exclusive Agriculture Zoning in order to qualify.

The town plans to have information sheets and maps available at the town hall.

Residents Asked to Participate in Outdoor Recreation Planning

All Troy residents and property owners will be contacted in late spring, by mail, with directions to visit a link on the town's website. This link will provide the town's current park and recreational information, and ask for feedback to consider future improvements, amendments or additions to the town's outdoor recreational facilities. The Park Board is working with Cedar Corporation for planning assistance to complete and update our current 5-year Outdoor Recreation Plan.

Parks and Recreation Cove Boat Ramp

Located at 306A Cove Road.

Hours of Operation: 6:00 AM to 9:30 PM daily.

Permit Fees: Residents of Troy, \$6.00 Daily Fee; \$50.00 Annual Fee.

Non Town of Troy residents: \$8.00 Daily Fee; \$80.00 Annual Fee.

Annual stickers for use of Cove Boat Ramp can be purchased at the Troy Town Hall and the Town Recycling Center during regular business hours or by mail. Permits are required year-round.

Glover Park

Located at 428 Glover Road.

Hours of Operation: 8:00 AM to 1/2 hour after sunset daily.

Drinking water, restrooms, electricity at the pavilion, 2 regulation-sized ball fields, approx. 2.5 mile trail system with benches and interpretive signage, large playground with accessible play activities, volleyball court, picnic tables, native and other flower gardens, restored prairie remnant, established coniferous and deciduous forest, and "pet stations" for dog waste pick-up.

Pemble's Access

Located at 193 Glenmont Road. Parking is limited. No daily fee.

Hours of Operation: Memorial Day through Labor Day, Pemble's Access is open daily from 10 AM to 1/2 hour after sunset. Before Memorial Day in May, and after Labor Day in September, Pemble's Access is open Saturdays and Sundays, from 11 AM to 1/2 hour after sunset. Facilities include a portable restroom.

Winter Use of Boat Ramp

Access to the river by foot, UTV, ATV, and snowmobile permitted ONLY across the boat ramp; use for ice fishing access if permit fee is paid and vehicle properly marked. No vehicles are allowed to cross the boat ramp or surrounding area on to the river. Parking is limited to designated parking stalls, cleared of snow, next to the "Boat Ramp Sign."

Fire Safety Tips

The DNR recommends if you live in an area where there are sandy soils, oaks and pines like much of Troy is, to remove dry matter accumulated over winter, from your yard that could help spread a fire. Consider removing trees where necessary to keep at least 15 feet between the branches from tree to tree within 30 ft. of a building. Prune branches up and away from the ground.

We all know that the environment usually begins to get dry at the end of June. About that time, we are celebrating the 4th of July with fireworks. Exploding fireworks cause the most fires. But even sparklers and fountains pose a significant threat in grassy areas. Please be mindful of fire danger to neighboring property as well as your own and follow fireworks laws.

The City of Hudson will begin construction of a new state of the art fire station this summer, very good news for residents in the northern part of Troy served by the Hudson Fire Department. The new station location on Ward Ave on top of the hill is only a block off I94 putting fire services much closer to Troy which will reduce run time to a fire. Approximate move in date to the new facility is February 2020.

Town Welcomes New Clerk

Grants Awarded for Glover Park

The town is pleased to announce that we have been awarded two grants from the Wisconsin DNR for improvements to Glover Park. One grant in the amount of \$45,654 will go toward the upgrade of Eagle Trail and Eagle Pass Trail. Project elements include engineering, maintenance, landscaping, seeding, signs and labor.

The other grant in the amount of \$144,145 will go toward the building of a **new multi-purpose building**. This project consists of a 24'x60' restroom, community kitchen and pavilion. It will be built so that it can also serve as a storm shelter.

Kudos to the Park Board for their work on these two projects and for securing funding! In addition to the funding from the two DNR grants, they have secured a \$100,000 Andersen Foundation Grant and another \$4,050 from other donations including Citizens State Bank, Wisconsin Credit Union, St. Croix Electric, 1st American Bank and Royal Credit Union.
