b.	With Electricity, plumbing or heating	Value calculated at \$20 per square foot. Minimum \$160 for the first \$2,000 of the structures value, plus \$3 for each additional \$1,000 of value (or fraction thereof) in excess of \$2,000

a.	Uncovered Decks, attached or unattached	\$125
b.	Covered Decks, gazebos, attached or unattached	Value calculated at \$20 per square foot. Minimum \$150 for the first \$2,000 of the structures value, plus \$3 for each additional \$1,000 of value (or fraction thereof) in excess of \$2,000
<b>6</b>	<b>Electrical Work</b> - including, but not limited to pools under 5,000 gallons volume with pump, receptacle, lights, circuits, new service, central air conditioning, hot tubs, spas, ponds with electrical pumps, etc.	
a.	One inspection and permit	\$100

<b>7</b>	<b>Gas Fireplace</b> - fireplaces are included at no additional fee in new homes and in a greater addition/alteration permit	\$100

a.	Minimum Fee	\$400 for the first \$2,000 of the structures value

14	<b>Non-Building Structures (Towers, etc.)</b>	
a.	Minimum Fee	\$125 for the first \$2,000 of the structures value
b.	Additional Fee	\$3 for each additional \$1,000 of value or fraction thereof as exceeds minimum value of \$2,000
15	<b>Moved Buildings</b> - For all moved buildings, (1)the well and septic serving a building being moved off site must be properly abandoned and closed within 60 days of moving; (2) a \$500 deposit is required at permit issuance toward well and septic abandonment costs and shall be refunded upon presenting satisfactory evidence of well and septic closure and (3) a building permit is required.
